<b>Method of Qualifying:</b>	<p><b>Qualifying fee:</b> Partisan candidates - \$9,619.38 No party affiliation candidates - \$6,412.92</p> <p><b>OR</b></p> <p><b>Petition process:</b> 6,074 valid petitions</p> <p><a href="#">DS-DE 104</a> Candidate petition Petitions must be submitted to the Supervisor of Elections office <b>prior to Noon, December 10, 2018</b></p> <p>The SOE shall be <b>paid in advance</b> the sum of 10 cents for each signature verified (FS 99.097)</p> <p>If a candidate cannot pay such charges without imposing an undue burden on personal resources or on the resources otherwise available to the candidate, an <a href="#">Affidavit of Undue Burden</a> may be filed with the SOE to have the signatures verified at no charge (FS 99.097)</p> <p>Prior to disposing of surplus funds in the campaign account, a candidate (excluding a write-in-candidate) who qualified by the petition process and filed an <i>Affidavit of Undue Burden</i> to waive the petition signature verification fee, must reimburse the SOE the amount of the waived fee (FS 106.141)</p>
