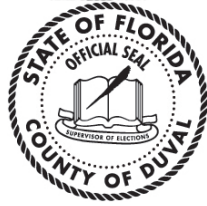

Method of Qualifying:	<p>Qualifying fee: Partisan candidates - \$10,179.36 No party affiliation candidates - \$6,786.24</p> <p>OR</p> <p>Petition process: 6,074 valid petitions</p> <p><u>DS-DE 104</u> Candidate petition Petitions must be submitted to the Supervisor of Elections office prior to Noon, December 10, 2018</p> <p>The SOE shall be paid in advance the sum of 10 cents for each signature verified (FS 99.097)</p> <p>If a candidate cannot pay such charges without imposing an undue burden on personal resources or on the resources otherwise available to the candidate, an <i><u>Affidavit of Undue Burden</u></i> may be filed with the SOE to have the signatures verified at no charge (FS 99.097)</p> <p>Prior to disposing of surplus funds in the campaign account, a candidate (excluding a write-in-candidate) who qualified by the petition process and filed an <i>Affidavit of Undue Burden</i> to waive the petition signature verification fee, must reimburse the SOE the amount of the waived fee (FS 106.141)</p>
