



LEGAL NOTICE

Pursuant to F.S. 98.075(7), notice is hereby given to the voters listed below. Please be advised that your eligibility to vote is in question based on information provided by the State of Florida or the Clerk of the Court and Comptroller. You are required to contact the Supervisor of Elections in Duval County, Florida, no later than thirty days after the date of this notice to receive information regarding the basis for the potential ineligibility and the procedure to resolve the matter. This includes the right to request a hearing for the purpose of providing information to substantiate your status. Failure to respond will result in a determination of ineligibility by the Supervisor of Elections and your name will be removed from the Florida Voter Registration System.

If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the Supervisor of Elections in Duval County within two days after the election and present evidence that you are eligible to vote. AVISO LEGAL

De conformidad con F.S. 98.075 (7), por la presente se notifica a los votantes que se enumeran a continuación. Tenga en cuenta que su elegibilidad para votar está en duda según la información proporcionada por el Estado de Florida o el Secretario del Tribunal y el Contralor. Debe comunicarse con el Supervisor de Elecciones en el Condado de Duval, Florida, a más tardar treinta días después de la fecha de este aviso para recibir información sobre la base de la posible inelegibilidad y el procedimiento para resolver el asunto. Esto incluye el derecho a solicitar una audiencia con el fin de proporcionar información para justificar su estado. La falta de respuesta resultará en una determinación de inelegibilidad por parte del Supervisor de Elecciones y su nombre será eliminado del Sistema de Registro de Votantes de Florida.

Si intenta votar en un sitio de votación anticipada o en su lugar de votación normal el día de las elecciones, se le pedirá que vote con una boleta provisional. Si vota por correo, su boleta será tratada como una boleta provisional. En cualquier caso, su boleta no puede ser contada hasta que se tome una determinación final de elegibilidad. Si desea que su boleta sea contada, debe comunicarse con el Supervisor de Elecciones en el Condado de Miami-Dade dentro de los dos días posteriores a la elección y presentar evidencia de que es elegible para votar.
